Privacy and cookie statement rev.02

Article 1: PERSONAL LIFE SPACE / PRIVACY

- 1.1. Personal data of the user are included in the EVENTALIX databases. These personal data are protected by the law of 8 December 1992 for the protection of privacy with regard to the processing of personal data (the "law of 8 December 1992") and the General Data Protection Regulation of 24 May 2016 ("AVG": Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing of the Directive 95/46/AG).
 - EVENTALIX cares for the monitoring and safeguarding the privacy of the user. The user who organises an event is aware that he himself has to check whether extra measures have to be taken to secure the personal information he has obtained through the registration of third parties and to guarantee the protection of the privacy of this user(s).
- 1.2. For the proper functioning of EVENTALIX, personal details of the user and possibly his or her responsible person are requested upon registration. No more data is required than is strictly necessary for the organization of the event and the proper functioning of the site.
- 1.3. If a minor, younger than 16 years old, wishes to use the services of EVENTALIX and in doing so it would be intended to provide, request or record certain personal data, he will have to have explicit permission from his parent or guardian, which latter will also be considered as a user.
- 1.4. EVENTALIX reserves the right not to admit the user to EVENTALIX if this information is not provided or incomplete. EVENTALIX guarantees that the data of the user is sufficiently secure and respects the laws and regulations with regard to confidential information.
- 1.5. The user has the right to inspect, modify, delete and download his personal data, by adjusting in EVENTALIX or contacting the EVENTALIX user service. A complete deletion is only possible if the collected data are no longer necessary for the purpose for which they were given, i.e. the event has ended and/or, at EVENTALIX's own discretion, all commitments taken by the user have been carried out.
 - A user who wants to inspect, modify, delete or download his data can do so on the EVENTALIX website after logging in. Once logged in, the user must go to his profile to inspect, modify, download or request deletion of his data. The user can also change the password for the account at any time in the profile.
- 1.6. The personal data are processed by EVENTALIX for the execution of this agreement, under the control and only according to the data supplied by the user. The user therefore acknowledges to be the controller for the processing of this personal data, and these personal data are processed by EVENTALIX only in its capacity as processor.
 - The collected information can in order to keep the cost for the user nil or as low as possible be used by EVENTALIX for commercial purposes, analysis, marketing, product development, etc.
- 1.7. The user organizing an event is responsible for the proper processing of the data of the user who subscribes for an event EVENTALIX will, if necessary, take the necessary measures to safeguard the rights of these third parties, even if this means that the data of the user/subscriber must be retained.
 - The user confirms that he fully complies with the obligations imposed on the controller by the law of 8 December 1992 and the GDPR.
 - Consequently, with the exception of the specific obligations contained in this agreement, EVENTALIX does not bear any responsibility for the processing of personal data that the user would manage. EVENTALIX will not be held liable for this at any time and the user undertakes to indemnify EVENTALIX in this respect in full for any claim or claim of any third party for breach of the obligations for processing imposed on the controller by the law of 8 December 1992 on the GDPR. Each party that is not a party to this agreement is considered a third party.
- 1.8 EVENTALIX will take the necessary technical and organizational measures necessary for the protection of personal data against accidental or unauthorized destruction, access, loss, manipulation and any other unauthorized processing of personal data.

Article 2: Cookie statement

- 2.1. This Cookie Statement is applicable to the online platform http://www.eventalix.org/ and possible derivatives.

This Cookie Statement clarifies which cookies are used on the online platform. By visiting, or using the online platform, the user agrees to the use of cookies as described in this statement and, if necessary, sharing the information obtained with third parties, with a view to optimizing and personalizing our services. The use of cookies by EVENTALIX is part of the protection of privacy and the processing of personal data.

2.2. "Cookies" are small information files that are stored temporarily or permanently on the computer, tablet, smartphone or other device by the server of an online platform via the browser. The cookies contain a unique code that allows the browser to be recognized during a visit to the online platform. There are technical cookies (eg. the language setting), session cookies (temporary information) and tracking cookies (cookies that register the use of this online platform).

Cookies allow you to simplify, complete and personalize the use of an online platform.

EVENTALIX uses Google analytics and Facebook pixel analysis to optimize the functionality of its site and services.

- 2.3. The EVENTALIX online platform uses different types of cookies:
 - a) Necessary and functional cookies
